

It is coming to a pretty pass when a God-fearing gentleman like Col. Love is not safe in his own private office from the attack of an assasin. Hill had hitherto borne a good reputation and it is believed he was suffering from temporary insanity. Col. Love was buried at Tehuacana.

A Perfect For All Throat and Cure: Lung Troubles. To Enforce Sunday Law.

County Attorney R. F. Holloway requests that we publish the law concerning Sunday selling of wares. It reads as follows:

Art. 199.—Any merchant, grocer, or dealer in wares or merchandise or trader in any business whatever or the proprietor of any place of public amusement, or the agent or employe of any such person who shall sell, barter or permit his place of business or place of public amusement to be open for the purpose of traffic or public amusement on Sunday shall be fined not less than \$20, nor more than \$50.

Knowing that many of our good citizens like to have the privilege of buying candy, fruit, cigars and cold drinks during their Sunday leisure hours, and the fact that dealers are allowed by law to sell ice cream, milk and perishable fruit at all hours, THE BRAND editor effected a compromise between the dealers to the effect that their places of business are to be closed between the hours of 9 a. m. and 4 p. m. on Sunday and at times other than those hours they are allowed to sell anything in their store.

By this arrangement these places will be closed during the different religious services, while a strict enforcement of the law would allow them to keep open and sell the wares exempted by law.


