We have been informed by William Coo-ley, Esq. who has arrived at this place, that on the 4th, when the attack and murder was committed on his family by the Indians, he was absent at the wreck of the Spanish Brig Gil Blas .- That on arriving at the Light House, Cape Florida, and learning that an attack had been made on his family, he proceeded to the melancholy scene accompanied

Our hereaved friend and neighbor caused the bodies of his loved ones to be as decently buried as circumstances would admit, and returned to the Light House on the 10th.

POST OFFICE BILL.

In the House of Representatives, the Post Office Committee reported a Bill for reorganizing the Post Office Department. The Intelligencer gives the following account of its

[This bill, which consists of thirty-seven sections, proposes that the revenue, arising in the Post Office Department, and all debts due to the same, shall, when collected, be paid, under the direction of the Postmaster General, into the Treasury of the United States; that estimates of the amount neces sary for the service of the Department shall be laid before Congress annually, under the several heads of Compensation of Postmasters; Transportation of the Mails; Ship, Steamboat, and Way Letters, Wrapping Paper; Office Furniture; Advertising; Mail Bags; Blanks; Mail Locks, Keys and Stamps; Mail Depredations and Special Agents; Clerks, &c. for offices; and Miscellaneous, and that annual accounts of the expenditures under these several heads should also be laid before Congress: that the appropriations for the service of the Post Office Department, to be made annually by Congress, shall be disbursed by the Treasurer out of the moneys paid into the Treasury to the credit of the said appropriation upon the warrants of the Postmaster General, registered and countersigned as provided by this bill, and expressing on their faces the head of appropriation to which they should be charged: that the accounts arising in the Post Office be audited by an Auditor of the Post Office, (a new officer,) with an appeal to the Comptroller of the Treasury: that duplicates of all contracts for carrying the mail shall be lodged with this new officer within ninety days after they are made, and he shall also have delivered to him, upon the death, resignation, or removal of any postmaster the bond of office of said postmaster, &c. that there shall be employed by the Post-master General a third Assistant Postmaster General, one Chief Clerk, three Principal Clerks, and thirty-three other Clerks, one Messenger, and two Assistant Messengers, and, in the office of the Auditor of the Post office Department, one Chief Clerk, four Principal Clerks, and thirty-eight other Principal Clerks, and thirty-eight other Clerks, one Messenger, and one Assistant Messenger.
