## Nicole Simpson, The Trophy

Nicole Brown Simpson was the kind of woman you fantasize about.

She typified the mythical California beauty of Beach Boys songs and Sunset Boulevard. Blonde, tanned, healthy and wonderful just to look at.

No doubt, to O.J. Simpson she symbolized much the same. She was a trophy to put on the mantel with the Heisman Trophy and his All-American and NFL most-valuable-player trophies.

When they met, Nicole was a high school senior and O.J. was at the height of his NFL glory. O.J. was 29, married, and a father; Nicole barely an adult. O.J. should have known better.

But, like many of us minorities, O.J. identified with his oppressors. Anyone who has read "Portnoy's Complaint," Philip Roth's hilarious novel about a Jewish boy who longs for the ultimate WASP princess, can understand and appreciate the syndrome.

For all his triumphs, it seems to me, O.J. could never have truly felt that he had conquered white America until he had slept with it, possessed it. So have other successful black men and Latinos.

O.J. has probably never even consciously realized this. Even when you do, you deny it. And at the beginning, when she was being wined and dined by one of the most famous men in America, Nicole Brown probably had no idea of the role she was being asked to play in O.J.'s psyche.

It said a great deal about O.J.'s success and his acceptance that the news media never made much of the racial aspect of his relationship with Nicole -- nor has it even in the wake of her brutal murder in the driveway of her Brentwood, Calif., condo.

Can you imagine the fuss that might have been made over race in the relationship had it been former football great Jim Brown, who once

aroused racial passions across the United States for an on-screen love scene with Raquel Welch?

But that shows just how we all came to love, admire, respect and look upon O.J. Simpson as a hero and a legend for whom race was of no concern.

My admiration and envy of him increased even more the day I met Nicole Brown Simpson. I was a writer for Sports Illustrated at the time, hanging out with then-Los Angeles Raiders' running back Marcus Allen, about whom I was writing a story. Allen was decorating his new condo, and his decorator turned out to be none other than the wife of his friend, O.J.

Nicole struck me as missing a sure thing. In a city like Los Angeles, you expect women as gorgeous as Nicole to be looking for movie parts instead of antiques and prints. Think of Sharon Stone in the film "Basic Instinct," and that's the kind of hypnotic effect Nicole Brown Simpson could have on you.

Over lunch, I asked. Why wasn't she in movies?

She shook her head. I got the distinct impression that it wasn't a subject to be discussed and, more to the point, that O.J. had put his foot down over the idea.

I guess I envied O.J. at that moment, not because of his fame but because of the kind of woman he could attract. Still, to me, he seemed insecure.

By then, I had learned from my own insecurities that putting prison walls around the person you claim to love isn't real love but a sickness that sooner or later kills any true feelings in the loved one. Or, as Sting's song that we listened to in Allen's Ferrari that afternoon put it, "If you love someone, set them free."

Ultimately, though, if you love somebody for all the wrong reasons, something bad is bound to happen.

I wasn't too surprised a few years later to hear of O.J.'s

arrest for beating up his wife after a New Year's Eve fight. I certainly wasn't surprised by their divorce. Nor was I surprised to see them together later, attempting to reconcile.

People get together with each other for all kinds of reasons. Especially in L.A., where fantasy, reality and absurdity are sometimes one and the same. It's a town full of famous people's dirty crimes

that others pay to expose but no one gives 2 cents to prosecute.

In the end, I wasn't even too surprised when I heard the news that Nicole was dead.

I guess I was just surprised she lived so long.

## Nicole Brown Simpson El Trofeo

Nicole Brown Simpson era la clase de mujer sobre la cual uno se hace fantasías.

Ella ejemplificaba a la belleza mística de California de las canciones de los Beach Boys y del romance de tarjeta postal de Sunset Boulevard: Rubia, bronceada, saludable, bella más allá de la realidad y maravillosa sólo con mirarla.

No hay duda de que, para O.J. Simpson, ella simbolizaba mucho de eso. Ella era un trofeo para poner allí, sobre la repisa de la chimenea, con el Trofeo Heisman y todos esos trofeos suyos de "All-American" y de la Liga Nacional de Fútbol Americano, como jugador más valioso.

Con todos sus triunfos, O.J. nunca habría sentido verdaderamente que él había conquistado a los Estados Unidos

blancos hasta que durmiera con ellos y los poseyera. De igual modo les ha pasado a los otros negros y latinos que han tenido éxito. La sensatez, después de todo, no tiene nada que ver con el éxito.

O.J. nunca se ha dado cuenta de esto probablemente, ni siquiera conscientemente. Aún cuando uno se da cuenta, lo niega. Y al principio, cuando uno de los hombres más famosos de los Estados Unidos la invitaba a comer y beber, Nicole Brown no tenía idea del papel que se le estaba pidiendo que desempeñara en la psiquis de O.J.

Dijo mucho acerca del éxito y la aceptación de O.J. que los medios informativos nunca se ocuparon mucho del aspecto racial de su relación con Nicole -- ni siquiera en la estela de su asesinato brutal en la entrada de su condominio de Brentwood, California.

¿Pueden ustedes imaginarse la alharaca que podría haber habido por el asunto racial en la relación, si hubiera sido el ex-grande del balompié, Jim Brown, quien provocó una vez las pasiones raciales en los Estados Unidos por una escena de amor en la pantalla con Raquel Welch?

Pero eso muestra exactamente cuánto llegamos todos a amar, admirar, respetar y mirar a O.J. Simpson como a un héroe y una leyenda, por el cual la raza no era de preocupación alguna.

## News Briefs

### Guadalupe Gets Grant

TGuadalupe Economic Services Corporation, a local non-profit organization recently purchased Timberwood, a 128-unit apartment complex in Oklahoma City. The \$2.2 million purchase was financed through bonds issued by the Oklahoma County Finance Authority. Part of the bond money will be used to install new carpeting, stairwells and other improvements.

Guadalupe will act as co-manager of the complex along. At least 20% of the units will be reserved for a 30-year period for families earning less than fifty percent (50%) of median income level.

The low interest rate afforded by the bonds allowed Guadalupe to purchase the property without any down payment. The acquisition is part of Executive Director Richard Lopez's plan to expand Guadalupe's single and multi-family dwelling programs. Other multi-family project acquisitions are planned in the near future.

During the same week that the Timberwood property was purchased, Guadalupe received a \$416,000 HOME grant from the Texas Department of Housing and Community Affairs for its First-Time Homebuyers Program.

Under the program, Guadalupe will rehabilitate repossessed homes purchased from HUD, FHFA and RTC and real estate agents and sell them to qualified applicants through an arrangement which affords homeownership to families who successfully lease their homes and complete homeownership classes. Another facet of the program is the home improvement loans which will be available to the rural areas under this grant.

Guadalupe was the only West Texas recipient of the grant under the State Program. More information about the program will be released during August.

### NEA Against Denying Services to Undocumented Immigrants

AP reports that the 2.2 million member National Education Association voted to oppose a California state initiative that would deny social services to undocumented immigrants. "California makes it a sin to be a child of a person who is seeking the American dream," said Darlene Chavez, granddaughter of an undocumented immigrant and an Arizona delegate to the NEA's annual convention.

During the debate, Amy Tsubokawa of California recalled how she was interned with other Japanese Americans during World War II and how she was denied equal access to public education. She also described the trust that develops between students and teachers and said, "I do not want my students to think the very people they trust will turn them in to the INS."

The California delegation had asked the NEA to take a broader approach, actively opposing any legislation that would deny undocumented immigrants equal access to public education and other services. But its motion was narrowly defeated.

### Poll: 69% Want Health Care Reform

The Gallup Organization reports that 69% of those responding to a poll say they want health care reform. When asked about certain provisions currently being debated in Congress, the survey respondents showed a strong consensus in several areas: 77% favor universal coverage compared to 17% who said they are against it. If Congress passes a bill without guaranteed coverage, 62% want Clinton to veto it; 44% said employers should pay most of the costs of the insurance, while 8% said employers should pay all of it. 37% were willing to share the costs equally. Four percent said workers should pay for most of it, 3% said workers should pay for all of it.

Sixty-nine percent said they wanted coverage for catastrophic, long-term illnesses. In terms of other important elements in a new health care system, 45% survey respondents wanted nursing home care coverage, and 39% said they'd like coverage for prescription drugs. Most respondents were opposed to government-financed abortions. The poll was based on telephone interviews with a randomly selected national sample of 1,019 adults. Margin of error is 3 percentage points.

### Supreme Court Rulings

The Los Angeles Times reports that the Supreme Court ruled yesterday that judges and lawmakers can create a small "buffer zone" around an abortion clinic and prevent protesters from picketing near the facility. The court said in a 6-3 vote that the limited ban on peaceful protest does not violate the First Amendment, so long as it is deemed necessary to preserve the patient's right to enter a clinic.

However, in the same case, [Madsen vs. Women's Health Center], the justices ruled that a Florida judge went too far when he barred protesters from seeking to speak with any patient or staff within 300 feet of a clinic. The court said these restrictions on free speech, "sweep more broadly than necessary" to protect access to the clinic and are therefore unconstitutional.

AP reports that in other Supreme Court decisions, the justices ruled in a Florida case that the federal voting rights law does not require creation of the largest possible number of minority-dominated election districts [Johnson vs. De Grandy, 92-519]; In Holder vs. Hall, 91-2012, the justices upheld a Georgia county's one-commissioner form of government against a Voting Rights Act challenge that said it diluted black voters' political clout; and in McFarland vs. Collins, 93-6497, the Supreme Court upheld the death penalty law in California, the state with the most death row inmates at nearly 400.

### East West Foundation Program Trades Computers For Guns

Newsbytes reports that the East West Foundation of Boston, Massachusetts is seeking sponsors for a program that encourages students to turn in guns in exchange for free computers and other equipment for their schools.

A decade ago, the foundation, formed by Boston Computer Exchange founder Alex Randall, began distributing thousands of portable computers to eastern Europe. Under its latest program, East West would offer an XT system with a printer for any handgun, an AT system with modem and printer for any shotgun or rifle, and a complete desktop publishing system for an automatic weapon.

# El Idioma Como Instrumento de la Democracia

El idioma puede unir a un pueblo. Puede edificar a un país. Los proponentes del Inglés Solamente son descuidados por su fracaso para saber esto.

where. Their westward trek over waterways like the Quonektact, the Missouri, and Maesi Sipu led them to aboriginal homesteads in Massad-chu-es-et, Indiana, Michi Gama, and on to the Spanish settlements of California.

"Language is a city," Emerson said, "to the building of which every human has brought a stone."

Indeed. Our common tongue traveled the world arriving here. It grew alongside the development of our nation, proving that language can indeed unite and build. If anywhere the melting pot theory is evident, it is in the metamorphosis of our universal vocabulary. We are a great nation not only by the words of one race alone.

Even the early demographics of the United States debunk the one-culture theme. Less than 2 per cent of the English language, moreover, comes from the British Isles. This is a country of international people.

As English conveys the vision of a democratic spirit, in the dream of brotherhood lies the beauty of our linguistic terrain. Tongues may slip and slide, trip, stammer or cluck -- but as we progress toward fluency, demonstrating that language assimilation works both ways, we discover the intrinsic value of English. We find each other. The me in you, the you in me. A commonality.

Anything less is an invitation to destruction. Our barrios, ghettos, and reservations are proof enough. In them are stasis, animosity, atrophy and death. With the dissolution of fellowship, civilization will crumble, one community at a time. Make no mistake about it, there is no monolingual Eden. Not even the Supreme Court can make it so.

And how ludicrous the proposal for English Only. Its advocates fail to see the absurdity

## FCNL: Health Care Legislative Update

This is the Friends Committee on National Legislation with updated legislative information. To speak with a staff member, call (202) 547-6000. This message was prepared at 6:00 p.m. on Friday, July 1. Due to the Congressional recess, it will not be updated until Friday, July 15. This message contains information and action suggestions on HEALTH CARE REFORM.

**HEALTH CARE REFORM.** The prospects for comprehensive health care reform are in major trouble. Congress is feeling the pressure of insurance, pharmaceutical, and other industries whose profit margins are affected negatively by universal access to affordable health care. And yet, it is very clear that the American people are ready for change in this area. We want universal comprehensive health care -- like other nations have.

We're at a fork in the road; one of two things will occur. Either (1) People will go and see their congressional delegation during the fourth of July recess and DEMAND action on health care reform in THIS congressional session, or (2) People will give in to cynicism and give up on Congress. Congress CAN adopt universal, comprehensive health care THIS YEAR. Members of Congress need to hear from the voters that THIS is the year for health care reform, and that we expect them to fashion a bill that works for ALL of us. The actions we take at this point will make a very big difference.

**ACTION:** Meet with your representative and either or both of your senators during the 4th of July recess. Urge them to adopt a health care plan that meets these criteria:

1. The health care plan must serve EVERYONE -- older, younger, employed, unemployed, urban, or rural -- regardless of income, health status, or citizenship.
2. We need a COMPREHENSIVE health care system, covering all BASIC health care needs.
3. Universal health care must be FINANCED FAIRLY, so that the cost of premiums does not fall too heavily on small businesses or on people with low incomes.
4. A new health care plan must CAREFULLY CONTROL the practices of private insurance companies; after all, they'll be making a profit from our premiums.
5. States must be able to adopt SINGLE-PAYER PLANS if they choose to control health care costs by leaving out the insurance "middleman."

This concludes our message.

If you step back and try to reflect on the big picture that folks living on the north and east side of Lubbock have been looking at over the years, you would see things like:

### Education:

\*Segregated school system.

### Housing:

\*One of the most segregated housing patterns in the country.

\*Discrimination and redlining by banks

\*Demolition of housing.

\*Discrimination in municipal services.

\*Limited construction of low to moderate income housing.

### Employment:

\*Employment discrimination.

(Lubbock police department....)

### Leadership:

\*Anglo attempts to control minority leadership.  
(Linda DeLeon,...)

\*Refusal to hire qualified minorities for professional positions:

(Look at the resumes for the finalists for LISD school superintendent, Chamber of Commerce director, and United Way director. Or the minority membership of the board of directors of local banks, law firms, corporations, Texas Tech faculty,...)

\*Black ball system of striking nominees to city boards and commissions.

### Health Care:

\*At one point Lubbock had the 7th highest infant mortality rates in the country with 20 out of 21 death being minority babies.

You could add a segregated cemetery, segregated county jail, the fight for a public accommodations ordinance to stop discrimination by restaurants and clubs.... And, of course, throw in the intellectual leadership and insight of good 'ole Jay Harris down at the Avalanche-Journal who would travel to racist South Africa and return singing its praises and worrying about what would happen if the black majority ever got the right to vote. Over the years we have also endured his nonsensical columns complaining about voting rights, desegregation of schools,...

Put it all together. Think about it. Look carefully at the picture. Our children are not blind. Think about its affect on them year after year when they are forming their ideas about their future.

Whether everything has been a coincidence or a conscience decision by the powers-that-be does not make much difference - in the end its effect has been the crippling of growth and development, the future, or our community on the north and east side of town. As the federal judge once said: "Blacks and browns residing in Lubbock County have long suffered from, and continue to suffer from, the effects of racial discrimination."

Of course, some things changed after a fight or exposure to the public eye. But you have to wonder how many years it will take to recover from the racist legacy-ten years, a generation? What type of aggressive affirmative action has been adopted by the powers-that-be to try to correct the history of injustice in Lubbock?

The majority of the children in the Lubbock public schools are minority. They are our future. How much advantage has the Anglo majority created for themselves and their children? What are we willing to do to insure that our kids simply have a fair opportunity to share in the American Dream?

Soweto or Lubbock. The song remains the same. The struggle will continue.
