
Chicano dropout still twice anglo




School District recently undertook an effort to address a most serious problem which is plaguing the educational community and particularly the minority students of Lubbock. The Dropout Rate is not unique to Lubbock though, with figures of up to 50% of Chicano students dropping out in some areas such as South Texas. Lubbock had a 49% dropout rate for Chicanos as recent as 1981 and as of may 1987,

are dropping out in Lubbock at a rate of 22%; anglos, 15% (Source: Lubbock Independent School

Taking into account the impact that such a drop-out rate can have in our society by the year 2050, action will have to be taken to stem that trend. Should the dropout rate not be eliminated or our paid of serious consequences. curtailed, serious consequences willk result affecting literacy or the absense thereof. Additionally ethnic demographics are changing so dramatically that by that same

will be the majority physically, but certainly not educationally. At the present rate of 37% and 20% the present rate of 37% and 20% respectively, for Chicanos and Blacks the illiteracy rate and people on welfare will simply overwhelm any efforts at maintaining the standards of living with which we are accustomed to. As minorities and other disenfranchised groups began demanding equality, and as the ugly effects of racism began to be exposed, those who were able

El Editor learned early Thursday morning that Maria Rivas, a Ph D. and a former professor at Texas Tech University, has called a Friday noon press conference at Guadalupe Park to protest the Lubbock school board's recent decision to try to stop federal court intervention in Lubbock's public schools.

Rivas' action is the latest development among leaders of the black and Hispanic communities ordered integration.

Informed sources told El Editor that among the subjects Hispanic leaders want to make public is the decision-making behind the

hiring of Kent Hance as a consultant for a fee of \$100,000

and \$10,000 expenses.

Those sources said "In matters of such significant financial commitments, the generally accepted governmental practice it is either go out for hide or request. to either go out for bids or request

providers of service."
Rivas' press co Rivas' press conferences follows a meeting held in an East Lubbock church Thursday night which focused on the possible effects of LISD's gaining unitary stsatus may have on the black community.

Trustee Linda DeLeon has filed suit against five LISD trustees, claiming she was denied due access to documentation relating to negotiations between attorneys for the Justice Department and LISD.

Additionally, three mothers of school children attending schools in north Lubbock have filed an intervention suit, on the premise that full minority representation may not be included among other suits filed in the city's 17-year old

desegregation history.

DeLeon said Wednesday that the alleged denial by LISD trustees of her right to study correspondence between the Jusstice Department and LISD constituents representation

to do something about it, insisted that they should not have to pay for their ancestors mistakes. That can be tolerated, but what is simply not acceptable is for those same representatives to fail to rectify the mentality that displays no vision. Sixty (60) years from now, people in power will say, in reference to the present dropout rate, "A majority of our society is illiterate because of decisions made in the 20th century, but why should we have to pay for past mistakes." And the cycle continues.

In the summer of 1986, it was announced that the drop-out rate within the Lubbock Independent School District (LISD) have to be confronted. The need for the formulation of a task result of the recommendations by forces was established and on the Task Force.

October 31, 1986 the Dropout Task Force for (LISD) was formally announced. The structure for the Task Force was for it to be divided into four (4) major committees of between 8-12 members per committee.

unwatched by one of its students working after school in a fast food place, the unitary status proposal approved last week with a 5-2 vote by the Lubbock Indpendent School District (LISD) is

bubbling over. Wednesday, a group of East Lubbock residents said they would hold a meeting Thursday night at Bethel Church to plan action against what they see as a possible attempt by the LISD to stop integration, reintroduce segregation, or both.

The meeting at Bethel church

comes on the eve of an early Friday morning meeting of LISD

The trustees wil meet, probably in executive, or secret, session to ratify the hiring of former Congressman Kent Hance, who earned \$110,000 for about two months of "consulting" on behalf of the LISD majority, who favor the district's application for unitary status.

In essence, unitary status would mean that LISD no longer discriminates against minorities, and would not need further federal Justic e Department approval for policies involving education of the district

EL EDITOR was unable to contact trustees or their attorneys, except Linda DeLeon and Leota

voted against the unitary proposal.

DeLeon is suing the five board members who voted in the majority when the trustees approved the push for unitary status last week.

DeLeon alleges that the five trustees who voted in the majority conspired against her by denying her proper access to correspon-dence between attorneys for LISD and the Justice Department, which hammered out the agreement LISD trustees

approved last week Thursday.

Matthews joined DeLeon in voting against the proposal, but they were outvoted by Board of Trustees President Gary O.

Farmer, Nancy Neal and Billy

Caviel's vote came as a surprise last January when the issue first arose. A black, Mrs. Caviel

represents the predominately black and Hispanic east side.

DeLeon said Wednesday night that she would vote against the ratification of Hance's

consulting. "He's my adversary attorney," she said.

DeLeon also said her lawsuit could have bearing on the final decision, which will be made by Federal District Judge Halbert O. Woodward. The judge can grant LISD full unitary status, approve unitary status with conditions, or reject the proposal outright.

Tragedia del contrabando de indocumentados

La semana pasada ocurrió otra de las tristes historias de indocumentados introducidos de contrabando y que puerden la vide en forma angustiosa.

Eran 18 personas las que murieron dentro de un vagón de carga de un ferrocarril, bajo el intenso calor en el oeste de Texas. Las víctimas fueron puestas allí por personas que se dedican al contrabando de indocumentados, los famosos "coyotes", quienes cerraron el vagón con candado.

inmigrantes tados llegaron escondidos desde Ciudad Juárez, Chichuahua hasta el lado tejano del Río Grande, para llegar a la ciudad de El Paso. Esto ocurrió en las últimas horas de la tarde del

Una vez en El Paso, fueron escondidos en un vagón de carga en una terminal ferroviaria, junto al rio. Dos de los traficantes de indocumentados también entraron al vagón y una tercera persona se quedó afuera para cerrar el vagón con candado e impedir que los inspectores de la patrulla fronteriza los descubrieran. El ferrocarril, del cual hacia parte ese vagón, recorrió después unas 60 millas hacia el sureste, en horas de la noche, hasta un punto de inspección llamado Sierra inspección llamado Sierra nca, donde los cadáveres fueron descubiertos en la mañana del jueves, durante una inspección rutinaria de los vagones, 14 horas después. Mike Williams, jefe de l patrulla fronteriza de El Paso, dijo que lo que encontraron fue una escena grotesca: 18 de los 19 extranjeros habían muerto por el efecto combinado de calor y la falta de aire. La temperatura en el El Paso es muy alta en esta época del año, y se cree que en el vagón sobrepasó los 120 grados 'F'. Durante la inspección rutinaria

del ferrocarril los agentes de la patrulla fronteriza encontraron a 19 individuos dentro, 18 estaban muertos y solamente uno había sobrevivido. Este logró sobrevivir valiéndose de un garfio de acero y abriendo un agujero en el piso del vagón, por el cual metió la nariz y la boca para poder respirar. De acuerdó al testimonio del

sobreviviente, a los indocumen-tados se les prometió que el tren los traería a la zona metropolitana de Dallas-Fort Worth, donde encontrarían empleo para poder

pagar a los contrabandistas. Los trenes de carga han sido uno de los métodos favoritos de los indocumentados para alejarse de las regiones fronterizas, donde hay más vigilancia. Las autoridades calculan que el 14 por ciento de los inidocumentados se introducen a EE.UU. por este

Muchos han muerto y otros tantos han quedado incapacitados en accidentes sufridos en estos

trenes de carga. El 26 de julio del año pasado fueron encerrados en un vagón de carga 26 extranjeros en Laredo, Texas. Todos perecieron, con la excepción de dos, que fueron rescatados por la patrulla fronterios fronteriza.

De acuerdo a las autoridades de De acuerdo a las autoridades de Inmigración, ha disminuido notablemente el número de indocumentados que son capturados en la zonz fronteriza con México después que entró en vigor la nueva ley al respecto, la que hace más difícil que los indocumentados puedan conseguir empleo en EE.UU. Las detenciones han disminuido en un detenciones han disminuido en un 46 por ciento y en lo que va de 1987 han arrestado a unos 200,000 comparado con 360,000 en igual período de 1986.

Desafortunadamente, la gran atención que los medios de difusión han dado a la noticia, bien podría ser la razón principal para que nunca sea encontrado y capturado el contrabandista ("coyote") responsable por la muerte de los 18 indocumentados

. Bill Harrington, sub director de la Patrulla Fronteriza de El Paso, dice que desde que los periódicos locales publicaron el apodo del contrabandista ("El Chapulín"). es muy probable que el hombre se baya aleido del áras. haya alejado del área.

Mientras haya pobreza en un país y el atractivo del dólar en la nación vecina, habrá quienes arriesguen sus vidas y los contrabandistas que se enriquezcan aprovechando situación.

Justo un día después de la terrible muerte de los 18 indocumentados, la Patrulla Fronteriza descubrió a otros once en otro tren en el mismo punto de inspección de Sierra Blanca.

Mensualmente las detenciones

de indocumentados en ferro-carriles de carga llegan a un promedio de 2 mil.

Empero, estas clases de preguntas han sido formuladas por los funcionarios del Servicio de Inmigración y Naturalización a inmigrantes legales ansiosos que desean convertirse en ciudadanos de los festados Unidos.

de los Estados Unidos. Extravagantes como son, pueden llegar a ser más comunes a medida que el Servicio de Inmigración y Naturalización se las entiende con la puesta en prática del nuevo programa de

legalización.

Hasta ahora, el Congreso, el Hasta ahora, el Congreso, el Servicio de Inmigración y la mayor parte de los dirigentes públicos han dejado de mirar más allá de la fase inicial del programa, la de presentación de documentos

- que terminará el 4 de Mayo de 1988 - hacia lo que se llama "el segundo paso de la legalización." La Ley de Reforma y Control de la Inmigración de 1986 exige que los extranjeros indocumentados pasen un examen verbal de conocimiento del inglés e historia de los Estados Unidos - muy de los Estados Unidos - muy parecido al que se administra durante los exámenes para la ciudadanía estadounidense - a fin de terminar con éxito el trámite de

la legalización.
Si sirve de norma el modo de administrar el programa del Servicio de Inmigración para los servicio de Inmigración para los inmigrantes legales, se avecinan problemas graves para el programa de legalización.

Por ejemplo, de las 500,000 personas que solicitan la ciudadanía estadounidense cada

año, aproximadamente la tercera no terminan el trámite debido a su incapacidad para pasar con éxito el examen de la ciudadanía por otras razones. Los solicitantes de la legalización tendrán que enfrentarse a este mismo examen de ciudadanía.

Si la tasa de fallos y retiradas para las personas que procuran la legalización es la misma que para los que solicitan la ciudadanía, entonces un estimado próximo a 800,00 de los 4 millones que se espera que soliciten la legalización puede de nunca completen el segundo paso.

Una parte de la razón de la tasa elevada de fracasos para la naturalización es la naturaleza arbitraria del examen actual para la ciudadanía. El examen se desarrolla en el ambiente de una desarrolla en el ambiente de una reunión privada entre el examinador del Servicio de Inmigración y Naturalización y el solicitante. No hay preguntas normales para este examen verbal. No hay testigos del exterior presentes. No se escribe nada sobre las preguntas formuladas ni las respuestas

Unas reforma inmediata que dicha dependencia podría instituir sería la de normalizar el examen, tanto para la ciudadanía examen, tanto para la ciudadanía como para los solicitantes de la legalización. Debería de desarrollarse una lista de entre 50 y 100 preguntas importantes, y distribuírsele a todos los solicitantes. Durante el examen, el examinador podría plantear entre 5 y 10 de estas preguntas. De igual importancia y con igual necesidad de atención son los cursos de ciudadanía e inglés para los solicitantes que eligen

para los solicitantes que eligen cumplir los requisitos de la nueva

cumplir los requisitos de la nueva ley matriculándose en las clases. A partir de Mayo 5 último, los solicitantes tenían 12 meses para presentar sus modelos y documentos a fin de solicitar la situación legal temporal. Aquéllos a quienes se otorque esa situación deben de permanecer como residentes "temporeros" durante 18 meses. De ahí en adelante tienen un año para solicitar la situación de residentes permanentes. Con abjeto de calificar para la última, tienen que demostrar las "habilidades fundamentales de la ciudadanía el conocimiento del inglés y del gobierno e historia de los Estados gobierno e historia de los Estados Unidos - que se exigen a los solicitantes de la nacionalización, o bien estar "siguiendo satisfactoriamente un curso de estudio reconocido por el Secretario de Justicia" para adquirir dichas habilidades. Changing immigration law will be easier than living with it

The Immigration Reform and Control Act of 1986, signed into law by President Reagan last November, has created new November, has created new problems while failing to solve old

Employers, lawyers, farm orkers' union and minority rights advocates criticize the way the law has been implemented by the Immigration and Naturalization Service, while immigration specialists doubt that it will stop undocumented immigrants and refugees from coming to this

country.

Nearly three months after the law's legalization program has started, only a small portion of the estimated 3.9 million eligible people have applied. In no other Western country where a legalization program has been put into effect have conditions to qualify for legalization been so restrictive, expensive and ill-managed. Most immigrants have found that proving their eligibility is more of a nightmare than a

law's provision to control the labor market: employer sanctions. Not only are millions undocumented workers affected, so are every citizen and every legal resident of this country. Employers are required under penalty, to verify the legal status of all new employers hired after Nov. 9, 1986. As a result, Western states' growers have complained about labor shortages, U.S. farm workers are experiencing discrimination and nployers are confused about eir obligation and fear the impact of the law on their

The immigration act came into existence largely on assumptions and prejudices about undocumented immigrants: They take jobs away from U.S. citizens, they abuse public services, resist assimilation and damage the environment. These antiimmigrant sentiments are not new. Since the last century, every major influx of immigrants major influx of immigrants — Irish, German, Chinese, Italian, Jewish — provoked identical attitudes within sectors of the

population.

When the immigration law was passed, neither Congress nor any other institution knew for sure other institution knew for sure how many undocumented immigrants were living in the United States, how many arrived on a temporary basis and, most importantly, what positive or negative impact undocumented immigration had on the U.S. labor market, economy and population. Not even dramatic changes that were occurring changes that abroad - c at were occurring changes seriously affecting immigration patterns and U.S. international relations, such as the Central American war and Mexico's economic crisis – were taken into consideration in the immigration debate.

Its supporters admit that the law is not a panacea to solve all immigration-related issues, but they have praised it consistently as a humane and effective measure. Now there is much evidence that the law is causing the opposite of its intended purposes.

The law will not stop undocumented immigration.

On the one by

On the one hand, people will keep coming to escape poverty, war or persecution, even at the

risk of their lives.
On the other, key sectors of our

economy will continue to rely on massive immigrant labor to remain profitable and competitive. These push and pull factors, perhaps the most crucial aspect of immigration, were not addressed

Unfortunately, future undocumented immigrants and refugees, along with those already living in this country, will be forced to go further underground, where they will face conditions of harsher exploitation.

exploitation.

Filing for legalization will end in May 1988, while employer sanctions are a permanent fixture. Thus, citizens and leagal residents perceived as looking or sounding "foreign" will be easier targets of discrimination to the property of the property of the personnel. by employers and of harassment by immigration law enforcement

Finally, violence and abuse have been growing in the Southern border area of the United States, contributing to a poisoning of U.S. Mexico poisoning of

For all its shortcomings, the new law can have a significant result: to move the public and Congress to review it and to work a realistic and productive immigration policy that can serve justice and economic growth at home and cooperation abroad.

Changing the law will be a difficult task, but an easier one

than dealing with the problems it has brought about and with those it ignored.

Legalization's second step: pitfalls on the path

On your most nervous day,

could you answer --How many Pilgrims landed at Plymouth Rock?

Name the order in which the original 13 states entered the

Who was the sixth U.S. president? Even a college graduate with a

degree in American History would have trouble passing an examination with these questions

on it.
Yet, these types of questions have been asked by Immigration and Naturalization Service immigrants who want to become U.S. citizens

Outrageous as they are, they nay become more common as the INS grapples with implementing the new legalization program.

So far, Congress, the INS and most public leaders have failed to look beyond the program's initial filing phase -- which ends next May 4 -- to what is called legalization's "second step."

The Immigration Reform and ontrol Act of 1986 requires Control Act of 1986 requires undocumented aliens to pass a verbal English and U.S. history exam-- much like that given during U.S. citizenship examinations - in order to successfully complete the

legalization process.

If the way the INS runs the naturalization program for legal immigrants is an indication, serious problems for the legalization program loom.

For example, of the 500,000

people who apply for U.S. people who apply for U.S. citizenship each year, approximately one-third do not complete the process because of their inability to pass the citizenship exam or for other reasons. Legalization applicants will have to face this same citizenship

The 8th MENUDAZO!

If the failure and withdrawal If the failure and withdrawal rate for people seeking legalization is the same as for those applying for citizenship, then close to 800,000 of the 4 million expected to apply may never complete the second step.

Part of the reason for the high naturalization failure rate is the arbitrary nature of the present

arbitrary nature of the present citizenship exam. The test takes place in the context of a private meeting between the INS examiner and the applicant. There are no standardized questions in this oral exam. No outside witnesses are present. No transcript is made of the questions or the answers given.

Equally important and in need attention are the citizenship and English courses for applicants who opt to meet the new requirements by enrolling in

Beginning May 5, applicants had 12 months in which to submit their forms and papers for temporary legal status. Those granted that status must remain "temporary" residents for 18 months. Then they have a year to apply for permanent resident status. To qualify for it, they must demonstrate the "basic citizenship skills" - knowledge of English and U.S. government and history - required of naturalization applicants, or be "satisfactorily pursuing a course of study recognized by the Attorney General" to acquire such skills.

Those who are denied permanent residence will lose their temporary status after 31 months and be subject to deportation.

In need of attention now are the

In need of attention now are the In need of attention now are the citizenship and English courses for applicants who opt to meet the law's requirements by enrolling in classes. There are certain logistical problems that neither the INS nor the Congress have considered. considered.

English and citizenship classes currently are at a premium. In Los Angeles, for example, more than 40,000 people have been turned away from such adult education classes during the last year. Some Texas communities are facing similar backlogs, and the problem could become more severe as more people begin to file

Legalization applicants have only five school semesters between the first step, which runs until May 1988, and the final time must demonstrate proof of enrollment in authorized

Unfortunately, little is being done to deal with legalization's

second step.

Rising Hispanic Child Poverty Rates Can Be Reversed Panelist at NALEO Conference Tell

Hispanic child poverty rates can be reversed if policymakers and community leaders begin focusing attention on ways to end their cycle of poverty, Rep. Edward R. Roybal (D-Calif.) said at NALEO's First National Conference on Latino Children in

Poverty.

"I challenge you to speak to members of Congress and local elected officials about the types of programs needed to lift Hispanic children out of poverty," Rep. Roybal said at NALEO's recent conference on Latino Children in Poverty. "The future leaders of our community are at stake — we our community are at stake -- we can't afford to let them fail," he told nearly 100 experts and policymakers from around the country at the daylong

conference.

NALEO's conference is the first national-level meeting addressing the needs of the approximately 40 percent of Latino children who live in poverty. While 10 percent of the nation's children are Hispanic, they comprise 20 percent of the nation's poor child

NALEO wanted to bring this appalling situation to the attention of national lawmakers and officials," said Dr. Harry Pachon, NALEO National

Panelists reported that the Latino poverty rate is the result of several factors, including the fact that Hispanics are often employed in lower-paying jobs and are dropping out of high school at rates higher than other groups.

rates higher than other groups.
San Antonio's AVANCE Inc.
Program Director Carmen Cortez said the organization's successful parent-child education program has helped end the intergenerahas helped end the intergenera-tional dropout cycle in the Hispanic community by addressing the educational needs of both parents and child. Dr. Marta Tienda, a sociology

professor at the University of Wisconsin Institute for Research on Poverty in Milwaukee, said structural factors, including an increasingly "race-coded" job increasingly "race-coded" job market, are the most important determinants of poverty in the Hispanic community. Panelists called for more constructive employment training and education programs to adequately prepare parents for the increasingly technological demands of the job market.

Also, among the findings in the

one-day conference:
• Hispanic families are larger than other U.S. families. Policies need to be developed to address the specific needs of larger, two-parent families, such as providing added earned income tax credits for larger families.

• Many federal social welfare programs do not have adequate outreach to the Hispanic community. For example, only one-fifth of eligible Hispanics take part in the Head Start education program, and only two-fifths Latinos eligible participate in the federal supplemental food program for Women, Infants and Children (WIC).

• Families of four with a wage earner working fulltime at a minimum wage job are \$4,021 below the poverty line. Hispanics are more likely to reside in these working poor families.

 Poor children in two-part households are not eligible for Medicaid benefits regardless of income in twenty-two states.

• Hispanic youths have high educational aspirations, however, teachers' educational expecta-tions of Latino youths' performance often are lower. As a result, Hispanic students are more often placed into vocational career paths rather than college

prepatory tracks. Only 10 percent of Latino students a complete a college degree.

Despite these statistics, those attending NALEO's conference stressed the need for more comprehensive research on Hispanics, particularly children.
"Until policymakers begin to focus attention on this situation and its causes, the problem of Latino children in poverty will continue to grow," said Dr.







San Jose To Receive Page 5 **Protection from Aerial Spraying**

On June 23, 1986 an anonymous complaint was filed with the Texas Department of Agriculture by residence of the San Jose colonia a/k/a the Hereford labor camp against a local aerial spraying service that had been spraying chemicals on fields near San Jose. The complaint was filed by Stephen C. McIntyre, staff attorney, Texas Rural Legal Aid, Inc., Farm Worker Division, Hereford,

The complaint requested that TDA investigate the aerial spraying and to take appropriate action to protect the health and safety of families living in San

After a year of investigation and negotiations a tentative agreement was proposed by TDA and agreed to by the aerial spraying service and TRLA on July 24th. The agreement includes posting a notice in English and Spanish at the offices of Migrant Advocacy Services, Inc. in San Jose. The notice is to include the name of the aerial sprayer nad farmer and the chemical. It will also include the date and time of the spraying. The agreement also includes a commitment to only spray when the wind is blowing away from the San Jose colonia.

"This is an important agreement for the people of San Jose. With the notice they will now have the choice between remaining in their homes with their children playing in the yard during the spraying or leaving the immediate are for a few hours," said McIntyre.

"We will monitor the effectiveness of the notice and the behavior of the aerial service. If this agreement is insufficient we will seek more protection from TDA," McIntyre said.



Market La Bamba Offers Test Of Latino

The answer may be found in one of many stanzas sung to a Latin American folk tune that U.S. audiences will hear a lot this

The film's music is decidedly Hispanic, its original score was written by Carlos Santana and Miles Goodman and all of Ritchie

Diamond Phillips, who plays Valens (whose real name was Ricardo Valenzuela), is a Texas-born Filipino with a "dash of Hispanie"

Hispanic.

Miles Goodman and all of Ritchie Valens' music is performed by Los Lobos, the East Los Angeles group that has most successfully combined Latino rhythms with rock since Ritchie Valens recorded "La Bamba."

Valens' singing voice in the movie belongs to "La Bamba's real star, "Lobos" lead singer David Hidalgo, who gets no biling in the film.

in the film.

But the film's most Latino

elements come from the creator Valdez, who made the smart decision to center his story around Ritchie's half brother Bob. Esai Morales, who at one point was considered for the Valens role, puts in a solid performance as the older brother

older brother.

Played by Morales, Bob is an alcoholic, womanizer and drug dealer, but also a loving son and brother, vulnerable to an environment that preferred his talented stepbrother.

Valdez uses Bob to inject the film with his own philosophizing. It is Bob who takes Ritchie to an old Mexican healer, who in turn gives us Valdez's interpretation of life as a snake that keeps emerging from its own skin.

The film itself is well done,

from its own skin.

The film itself is well done, considering it is as predictable as a film can be that's about a 17-year-old rock star whose climb to stardom is cut short by an airplane accident. "La Bamba" is rich with the music of its period and high on nostalgia. It probably will be helped by the push an already-successful soundtrack album is giving it. giving it.

Valdez is the first Chicano ever

to write and direct a film for a major Hollywood studio. Now he's done it twice. His Universal Pictures feature "Zoot Suit" won wide critical acclaim, but did not get the promotional push it deserved. That's where the otra

A statewide lottery is business' first choice (79 percent) for generating additional state revenue, followed by elimination of some sales tax exemptions (56 percent). The least popular choice to generate new funds is a personal income tax (10 percent).

Seventy-seven percent cited the attitude of political leaders toward business as the single most important factor in attracting new business to Texas. Other factors include an available labor pool, a strong commitment to education and a positive tax environment.

Business said the Governor and Legislature should assume a stronger role in attracting new

business to Texas.

Poll participants also believe by a four-to-one ratio - that Texas liability insurance laws should be changed to limit awards and control premium costs. The business community is almost evenly split on changing the state's Homestead Act to permit home equity loans for purposes other than making home improvements or payment of property taxes
