



Cowboys fight back for huge 15 -14 win over Post Antelopes

What does a football team do when facing a much favored opponent with a huge line, their own ranks thinned by injuries to just 5 reserves on the sidelines? Did this pooch help save missing man?


** The following true story is written without identifying the principals involved, at their request.

On October 5, a local producer sent one of his farm hands to the field to tandem disc an area. The following day, he went to the farm to check on the employee's progress, to find both the hand and his tractor missing. He returned to town, went to the employee's home and asked his wife if he was there. She was upset, and told him her husband failed to come home the prior evening. Now alarmed, the producer

reported the missing man and tractor to the Sheriff Department. Deputy Jerry Howard, Lieutenant Lisa Switzer and Investigator Rick Dickson went to the scene. They were able to track the tractor, which left the original farm heading west, until it went down a hard packed caliche road and they lost the trail.

They eventually found the tractor, pulled up to a pivot irrigation system, in park, the engine still running. Deputy Howard told CCN " At that time I was really concerned we would eventually find the man either injured or possibly dead".

The search party then were



stopped by an employee of the boll weevil eradication program, and when he learned they were searching for the missing man, reported he had seen a person on foot in a field of cotton nearby. The officers hurried to that area, and found the man, wandering aimlessly, clad only in his trousers. "That dog" was a Golden Labrador Retriever, 'Lucky', be-There, it was learned he had longing to a family living on a



Criminal cases in County Court

In county court October 12, Leonardo Villegas pled guilty to sexual assault. He was sentenced to adjudication of guilt, deferred. He must pay court costs of \$186, a fine of \$1500, and will be under community supervision ten years. He must establish a DNA record with DPS, and register as a sex offender. He must also undergo outpatient drug counseling at his expense.

On October 18, Maria Esther Lopez pled guilty to driving while license suspended. She was fined \$200 and must pay \$200 court costs.



Voters to decide on constitutional amendments ★

PROPOSITION 1: Revises the provisions for filling a vacancy in the office of governor or lieutenant governor.

This amendment clarifies who takes over the job of governor and lieutenant overnor if those elected to office cannot serve. The lieutenant governor take the governor's spot if the governor cannot fill out the term. The president pro em of the Senate would take the lieutenant governor's place until senato could elect a lieutenant governor to serve until the next election

PROPOSITION 2: Relates to the making of advances under a reverse mortgage and payment of a reverse mortgage.

This amendment revises the constitutional provisions authorizing revers nortgages and resolves conflicts between the Texas Constitution and federa law. It increases the minimum age of a borrower or borrower's spouse to 62 years from 55 years. It also would specify three methods by which advances could be paid to the borrower

PROPOSITION 3: Eliminates duplicative, obsolete, archaic and neffective provisions of the Texas Constitution

he amendment eliminates expired provisions and out-of-date language. For xample, it would eliminate provisions for a poll tax, references to county poo nouses and dates that have passed.

PROPOSITION 4: Authorizes the legislature to exempt property owned by charitable institutions from ad valorem taxation.

The amendment broadens the definition of charitable organizations, increasin the number that can qualify for an exemption from property taxes. Sma business incubators would qualify for exemption under the proposed change.

PROPOSITION 5: Allows state employees to receive compensation for serving as a member of a governing body of school district, city, town or other local government district.

The amendment allows state employees to be paid for service on loc government entities such as school district boards and city councils.

PROPOSITION 6: Increases the maximum size of an urban homestead to 10 acres, prescribes permissible uses of urban nomesteads and prevents the overburdening of a homestead.

The amendment, which increases the maximum size of an urban homestead from one acre to 10, allows the homestead to be used as a home or as both a home and place of business. The amendment allows home equity loans on all or part or urban homesteads of up to 10 acres. The principal amount of the loan who added to the total of the outstanding principal balances of all other indebtednes nowever, must not exceed 80 percent of the homestead's market value.

PROPOSITION 7: Authorizes garnishment of wages for the enforcement of court-ordered spousal maintenance.

The amendment provides that if an employee owes court-ordered spouse naintenance, a portion of that employee's wages may be withheld. Curren law allows such withholding only in the case of delinquent court-ordered chil

PROPOSITION 8: Provides that the adjutant general serves at the pleasure of the governor.

The amendment provides that the adjutant general, who is appointed by the governor and who serves as the governing officer of the state military forces, serves as long as the governor wishes, rather than serving a two-year term set by the Legislature.

PROPOSITION 9: Authorizes the Legislature to create a judicial compensation commission.

The amendment authorizes the Legislature to create a judicial compensation commission to make recommendations on salaries for the justices and judges of the Supreme Court, the Court of Criminal Appeals, the 14 courts of appeals and the 418 district courts. The recommendations would become law if neither the Senate nor the House of Representatives rejects them by majority vote.

PROPOSITION 10: Provides that the commission of health and human services serves at the pleasure of the governor.

The amendment provides that the commissioner of health and human services, who is appointed by the Governor, serves as long as the Governor wishes instead of serving a two-year term set by the legislature.

PROPOSITION 11: Permits a political subdivision to purchase nonassessable property and casualty insurance from an authorized mutual insurance company in the same manner that it purchases life, health and accident insurance.

Under current law, political subdivisions cannot purchase this type of insurance from mutual insurance companies

PROPOSITION 12: Authorizes the Legislature to exempt leased motor vehicles not held by the lessee primarily to produce income from ad valorem taxation.

e amendment authorizes the Legislature to exempt from property taxes motor vehicles leased for personal use. Vehicles leased for business use would


Irene Anderson, 89, of Denver City died Thursday October 21, 1999 in Denver City.



Texas, now 20 million strong, will continue its rapid population growth in the first decade of the 21st century. By 2010, the state will have 4 million new residents for a total of 24.5 million.


The state's population is expected to grow 19.7 percent between 2000 and 2010, according to the Texas Comptroller's office. That's just under the 1990's rate of 20.7 percent. The state's lowest growth rate in the 20th century was 10.1 percent in the 1930's. The national growth rate is about 10 percent per decade/

Texas grows because of a high

birthrate, a strong economy that attracts people from other state's and its proximity to Latin America.

Growth will continue to be concentrated in the urban areas. Williamson County in Central Texas is expected to have the biggest percentage change, growing 54 percent to 352,754 in 2010, up from 228,532 in 2000. More than 60 percent of the state's population will live in the state's five largest metropolitan areas.

Growth won't be as strong in rural areas. Forty eight percent of the state's rural counties are expected to lose residents during the decade.

Court OK's

computer wiring job

In Mondays session of Commissioners Court, Hospital Administrator Ed Rogers asked the court to authorize re-wiring of the computer system in the three Doctor's clinics in Denver City. Rogers said the old wiring had caused some \$40,000 damage to computers over the past few years during electrical storms. The old system will be replaced by a fiber optic T-1 line, linking all three offices together, and also the county hospital, with direct linkage to St. Mary's hospital facilities in Lubbock. The court authorized payment of \$7322 for the project, with St. Mary's picking up \$6500 of the bill.


Rogers also requested \$8500 in county funds for it's share of a recent Y2K compliance survey at the hospital by Hamilton-HMC. The survey revealed a number of problems in the electronic system at the hospital which did not meet compliance standards. The court authorized an amendment to the hospital budget for the amount.

In other business, the court authorized advertising for bids on two police package autos for the Sheriff Department, with trade-in of two 1996 Cherolet Caprice police package cars. 


