Church History The St. James Baptist Church was organized in 1945 under the leadership of Rev. W. L. Grimes in St. Paul Beptist Church which was located at East 25th Street and Date Avenue. Rev. Jackson was the Pastor, and Sister Ciara Grimes was the Secretary: Brother Argo James was Treasurer and Sister Annie Griffin was President of the Mission. There were seven members. A one room barrick was purchased and moved to the location at 2611 Cedar Avenue. Rev. A. L. Patrick was called to conduct a week revival for Rev. Grimes. Rev. Grimes worked very hard and did his very best to improve the little barrick with the few members he had. He pastored for six years.

Then Rev. B. R. Jones was called. He worked very hard, and made many improvements to the barrick building, adding on the front and also added a choir stand and Baptising Pool. He pastored eleven years, then his health begin to fail, forcing him to resign.

In 1961, Rev. Kado Leng was called to Pastor St. James. Being guided by God's vision and having lots of faith, he knew we needed a better place to worship. The building at 2611 Cedar Avenue was purchased by the Urban Renewal. The search was begun for an appropriate place for another Church. Two lots were

purchased at 3601 Railroad Avenue. Immediately a building was started, but due to the lack of funds, it stood unfinished for almost two years. Not giving up, our Pastor kept trusting in God and kept saying that he knew

God would not bring us this far to leave us.

Finally, financing became available. Rev. Lang and some of the members would meet at night and work. The building was completed at last. The Pastor faced many trials and tribulations, but he never gave up. Each year the accomplishments were greater for us. We are still toiling and laboring with our Pastor, Rev. Kado Lang, leading the way. Some kept the faith and fought a good fight. Others have fallen by the wayside, but the Church

We have come a long ways under the pastorship of Rev. Lang. We are not just St. James anymore. We are Greater St. James Baptist Church.

In 1987, we received word that again we would have to sell to the Urban Renewal, and

Greater St. James has had only three pastors since it was founded in 1945. Rev. Kado

### U. S. Navy Blue Angels Featured At Reese AFB

Colonel Mark H. Lillard, III, commander of Reese AFB's 64th Flying Training Wing has designated Sunday, October 16, 1988 as "Commanders Day" Open House.

The base will be open to the public from 10 a. m. to 5 p. m.

The featured flying attraction will be the U. S. Navy's Blue Angels Flight Demonstration team. They will be making their first visit to Reese in 20 years and will be flying their A/F 18 Hornet jet fighters.

More than 30, and possibly as many as 50 aircraft from all the military services will be on static (ground) display on the flightline when the gates open. The display will include fighters, bombers, reconnaissance, transports, helicopters and training aircraft.

Some of the more interesting aircraft currently scheduled to be on display are a B 1B bomber from Dyeas AFB in Abilene, Texas and a C/5 Galaxie, the Air Force's largest transport aircraft. Visitors will be able to walk through the length of the C/5 as it will be displayed with the front nose open and the rear ramp down.

Also on static display will be an F/16 Eagle, a F/16 Falcon, an A/10 ground support aircraft an F/4 and an RF/4 Phantom. Cannon AFB in Clovis, N. M. will send an F/111. Other transport aircraft will be a C 130 Hercules and a C/141

Starlifter.

A number of the latest militarry aircrafte are expected to fly by and give a demonstration of their flying maneuver capability. Reese's T/37 and T/38 training jets will fly by in formation prior to the Blue Angels show.

A number of exhibits and displays will be available for viewing. The Reese fire department will show the capability of their crash/rescue trucks and demonstrate a simulated extraction from a disabled aircraft. The Reese Honor Guard Drill Team and Color Guard will perform throughout the day.

There will be plenty of food, drink and parking available.

The Reese AFB appearance will mark the on appearance will mark the only Blue Angel flight demonstration in the West Texas, Oklahoma, New Mexico area between now and the end of their 1988 show season in November.



# EDITORIALS & COMMENTS & OPINIONS

It is reported that a seven month New York State grand jury inquiry has complied overwhelming evidence that Tawana Brawley fabricated her story of abduction and sexual abuse by a group of white men last year. The state. and its defenders of justice, have concluded that the black teenager concocted, either alone or with an accomplice, the degrading condition in which she was found. Black New York residents, and Blacks across the country, have acquiesced to the fact that the girl, age 15 at the time, smeared herself with dog do do and faked the semiconscious condition she was found in last

Did Tawana receive justice? Will Black Americans continue to accept the brand of law and law enforcement that is apparently reserved for "just us?" Do Blacks realize that the Brawley lawyers, Alton Maddox, Jr. and C. Vernon Mason along with the family's advisor, the Rev. Al Sharpton have introduced a new concept that could have profound impact on black civil liberties. Most Blacks do not understand what the group is saying in the U, S. profound impact on wack civil liberties. Most Blacks do not understand that what the group is saying is that we (Blacks) have never gotton a fair shake in the U.S. justice system and that they (Brawley and Company) refuse to cooperate with a process that is designed against us in the first place.

Even if you do not endorse the dress of hair style of Sharpton, the points on "Black Justice" that he makes cannot be ignored. Even if he looks like a street hustler, he currently illustrates that the legal system in this country has yet to treat blacks equally as whites. He questions how we can let the system discount the fact that 80 percent of the people incarcerated in the penal network are black? How can we let the white system of justice give Blacks harsher sentences than whites and still have us believe that we are fairly handled in the process of law enforcement and courts procedures?

To date, Brawley and her advisors, have refused to cooperate with the grand jury process in New York State. The reason for their noncooperation is that they don't believe that they can get one white man there to prosecute another white man in the interests of a lowly black female. The history of rapes and degradation of black women in the annals of this country is well documented in the minds and hues of Black people. C. Vernon Mason tells a story which all Blacks know to some degree. He tells of the white sheriff in his rural southern Georgia hometown who took a physical liking to an attractive Black woman in the community. Although he had no formal, or emotional, ties to the woman, the sheriff would come any time he desired, day or night, force the woman's black male partner to vacate the premises and proceed to violate her body, and her black companion's authority. After getting his sexual kicks, the sheriff would go back to work protecting the upstanding members of the community. Mason says that this symbol of our national racism will, and must, end with Tawana Brawley. Seeing that Black Americans have put so much of their faith and labors into the political system, and its process,

we should make it work for us. We should call on a Black Congressman, John Conyers, to convene a congressional hearing on racial violence at which Tawana could testify with some guarantee of receiving a

fair hearing.

To believe that Tawana put dog do do all over herself to fake a crime is to also believe a similar story from Black history and white folklore. The story goes: When the Black man was found floating face down in the river with chains around his arms and legs, the white police and judges were unanimous in saying, "Ain't that just like a nigger, he obviously stole more chains than he could carry.

A hoax in New York. Hardlyl Congressman John Conyers, head of the Sub Committee on Criminal Violence at (202) 225 5126 should be urged to be a major channel to make sure that Brawley's story will be heard and acted upon. Let's all give him a call.





Our drop out coordinator, Tom Brown, has come up with some really good ideas to help with the increasing number of drop outs.

Mr. Brown believes the new program, S. O. S. (Save Our Students) will really help the At Risk Student The Adopt A Student Program was presented by Mr. Brown to all principals at a staff meeting. Principals were encouraged to go back to their buildings, and urge their administrators, counselors, teachers and clerical personnel to volunteer by adopting an at risk student. Each adopter is to do the following:

A. Give the student someone to talk to ....

\* B. Anytime your adoptee is absent, call them personally or make a home

. C. Encourage the adoptees in any way possible, help them with homework or guide them to someone who can help

D. Talk with their parents, let the parents know you are working with

their child; and \* E. Find ways to reward them when they have done well or improved. You can do this with encouragement, a pat on the back, or by attending some school or out of school function with them.

In a similar program in Los Angeles, out of 125 students adopted, only 4 dropped out. Of course, elementary students cannot drop out, but daily encouragement will begin to help students know that they are and that supported someone does care about

This sounds like a great program that's going to work. The School System should introduce the Adopt A Student Program to all the schools. There are At Risk Students throughout Lubbock, but it seems thate Lubbock, but it seems that this program has only been introduced where there is a higher enrollment of minority students.

Are at risk studens only minority? Surely there are students at every school within LISD that needs someone that cares whether they are in school or not. Having the S. O. S. Program at minority schools sends a message that labels different areas of the city. Ignorance is our worst enemy. The denial to admit that we have At Risk Students at every school in Lubbock will hurt those students we don't reach.

Encourage a student to go back to school, S. O. S. (Save Our Students) is an excellant program that will pe of great banefit to any At Risk Student. 

Behavior is a story of a distinguish personage in the Old Testament of the Bible by the name, Hezekiah. It was said of him that he lived in the fear of the Lord and was one of the most pious kings of Judah. 

### DEATH PENALTY AND CAPITAL PUNISHMENT

One of the most Important Issues In our society today is CRIME and problem. SIN is the cause of all crime and therefore the answer to this problem is given In God's word and how to solve it. The revenger of blood himself shall slay the murderer: when he moeteth him, he shall sley him. But if he thrust him of hatred, or hurl at him by laying of walt, that he die; Or in enmity smite him with his hand, that he die: he that smote him shall surely be put to death; for he is a murderer: the revenger of blood shall slay the murderer, when he medieth him." In this same chapter verses 29-31 says "So these things shall be for a statute of judgment unto you throughout your generations in all your dwallings. Whose killeth any person, the murderer shell be put to death by the mouth of witnesses; but one witness shall not testify against any person to cause him to die. Moreover ye shall take no satisfaction for the life of a murderer, which is guilty of death; but he shall be surely put to death," and verse 33 says "So ye shall not pollute the land wherein ye are: for blood it dailleth the land: and the land cannot be cleansed of the blood that Is shed therein, but by the blood of him that shed it."

2. Rape. God says In Deuteronomy 22:25 "But 11 a man find a betrothed damsel In the field, and the man force her, and lie with her: then the man only that lay with her

3. Kidnapping, which would also include holding of hostages. Exodus 21:16 says "And he that steeleth a man, and selleth him, or if he be found in his hand, he shall surely be but to death." Deuteronomy 24:7 says "If a men be found steeling any of the children of Israel, and maketh merchandise of him, or selleth him; then that thief shall die; and thou shalt put evil away from among you."

4. Disobedience to parents. King Solomon, the wisest man who ever lived says in Froverbs 22:6 that we are to "Train up a child in the way he should got and when he foold, he will not depart from it." and the Apostle Paul says in Ephasians 6:1-4 "Children, obey your parents in the Lord: for this is right, Honour thy father and mother; Iwhich is the first commandment with promise;) That it may be woll with thee, and thou mayest live long on the earth. And, ye fathers, provoke not your children to wreth; but bring them up in the nurture and admonition of the Lord." If all parents would do this for the sake of their children, there wouldn't be very many broblems with their children. If our society would do what God says to do with problem children, they could be controlled. Notice what God says In Deuteronomy 21:18-21 "If a man have a stubborn and reballicus son, which will not obey the voice of his father, or the voice of his mother, and that, when they have chastened him, will not hearken unto them: Then shall his father and his mother lay hold on ' a, and bring him out unto the elders of his sity, and unto the gate of his place.
